

# **2025-2026 FINANCIAL INFORMATION**

The following is a list of school tuition and fees. Effective January 21, 2025.

#### **NEW STUDENTS (K-12)**

Application Fee: \$125.00 per student due with online application. **A FACTS financial account must be completed upon student acceptance**. Enrollment Fee: \$100 per student, increases to \$150 on March 14<sup>th</sup>, \$200 on April 25<sup>th</sup>.

#### **RETURNING STUDENTS (Grades 1-12)**

Continuous Enrollment (Student Commitment Fee): \$100 Each family is required to have an active FACTS financial account for the school year. Each family must have a signed Continuous Enrollment Form on file with admissions.

## PER STUDENT ASSESSMENT FEE (PSA)

(Includes: Curriculum/Field Trip/Technology/Yearbook/etc.) *Non-refundable* and paid via first FACTS payment of 25-26

Grades K-5	\$430 (includes Supply Pack)
Grades 6-8	\$525 (includes Supply Pack)
Grades 9-12	\$500

## **ANNUAL TUITION & ED CHOICE SCHOLARSHIP**

Tuition payments and school fees are administered through FACTS Tuition Management Company, an interest free, payment plan. There is a yearly \$55.00 set up fee charged per FACTS contract (one per family).

If the student's family does not qualify for low-income per Ed Choice guidelines, the family will be responsible for the difference in tuition (Gap Tuition). \*The State will be releasing their Max Ed Choice Scholarship amount for 25-26, but has not yet released the information.

Returning Families: If you renew your Ed Choice Expansion Application through the State for the school year and your income percentage goes up, you will be responsible for what the State does not pay and the difference in tuition.

#### **INTERVENTION PROGRAM ENROLLMENT FEE**

For any student enrolling in the Intervention Program K-12: \$750 (paid via FACTS monthly payment plan or due by August 1st)

# WITHDRAWL

After June 1<sup>st</sup>, families will be assessed a \$1,000 per student withdrawal fee, in addition to payment based on the number of days that each student was enrolled.

# INTRODUCTION

We believe that your tuition payments are an investment in your child's education and spiritual growth. Therefore, the school's Board of Education accepts responsibility for recommending policies concerning the amount of tuition, the manner of payment, and, in general, the development of policy in this area. Furthermore, it is the responsibility of the School Board to ensure that adequate financial resources are available for the school and that enrollment is as available and affordable as possible.

#### FEES

- Application Fee, Enrollment Fee, and Re-Enrollment Fee are non-refundable and non-transferrable.
- Per Student Assessment (PSA) Fee is paid via first FACTS payment or due by August 1<sup>st</sup> and is non-refundable.
- Life Skills: \$25.00 (required for all 7<sup>th</sup> Grade Students through PSA fee), \$50.00 (elective for High School students, addition to the PSA)
- Senior Graduation Pack: \$85.00 (see Senior Advisor for more information and to place your order)
- Devices, technology, non-consumable books, and library books will be evaluated at the end of the school year. Families will incur added charges for damaged or lost devices, technology, or books.
- If a family has not finalized their FACTS account for the upcoming school year, the family will be accessed \$25.00/month.

Students with any outstanding balances will not be admitted on the first day of the new school year.

## **TUITION PAYMENT**

All families shall be expected to make tuition payments through FACTS according to one of the following payment plans. Options for payment shall include:

- A. **Single Full Payment through FACTS:** Under this plan the entire amount of tuition is paid directly to MCS through FACTS in a single payment.
- B. **Monthly Payments through the FACTS Payment Plan-Automatic:** Under this plan the entire amount of tuition is divided into ten (10) monthly payments paid through FACTS by automatic deduction from your checking/savings account beginning in August. Payments can be set to process on either the 5<sup>th</sup> or 20<sup>th</sup> of the month.
- C. Monthly Payments through the FACTS Payment Plan-Credit Card: Under this plan the entire amount of tuition is divided into ten (10) monthly payments paid through FACTS by using American Express, Discover, Visa, or MasterCard beginning in August. Payments can be set to process on either the 5<sup>th</sup> or 20<sup>th</sup> of the month. A FACTS convenience fee of 2.95% will also be added for each payment.

#### LATE ENROLLMENTS

- A. Families enrolling after June 1<sup>st</sup> will pay their school fees and first month's tuition through FACTS. Any remaining tuition payments will be made through their FACTS payment plans. If a family has not finalized their FACTS tuition account, the student will not be permitted to start school.
- B. Tuition for students registering after the first day of school shall be prorated over the number of school days they will be in attendance, according to a formula established by the Finance Office. The family will then pay their school fees and first month's prorated tuition through FACTS. Any remaining tuition payments will be made through their FACTS payment plans. If a family has not finalized their FACTS tuition account, the student will not be permitted to start school.

#### LATE PAYMENTS

It shall be the responsibility of each school family to keep the Finance Office informed of their need to make any changes in their preferred tuition payment plan or adjustments in the amount of tuition expected to be paid. Without such information, the following policy will apply when payments are received after the due date.

A. **Full Payments**. If payments have not been received by the due date, the Finance Office will contact the family within five (5) days concerning the missed payment date and alternative tuition payment options will be offered.

B. **Monthly Payments.** Families will be charged a \$30.00 fee (by FACTS) if payment is not available for ACH or CC payment on the FACTS payment plan due date. Your bank may charge an additional NSF fee.

In addition, school families who have missed two monthly payments and have not made suitable arrangements within fourteen (14) calendar days of the second missed payment will be informed that their child/children will not be re-admitted to school according to the "Non-Admission" specifications of this policy.

#### NON-ADMISSION OF STUDENTS DUE TO TUITION DELINQUENCY

School families failing to pay tuition according to the agreement which they have made with the Finance Office, or who have been unwilling to make suitable alternative arrangements with the Finance Director, will be informed that their child/children will not be re-admitted to MCS. In addition to the policy that accounts must not be more than 2 months delinquent, **all families must be current in their payment of tuition:** 

By August 1<sup>st</sup>: If not, students may not be admitted on the first day of school.

By January 5<sup>th</sup>: If not, students will not be re-admitted on the first day of class in January.

By June 5<sup>th</sup>: If not, students will not receive report cards and permanent records will not be released by the school administration.

#### DELINQUENT TUITION FROM PREVIOUS YEAR(S)

All previously unpaid tuition must be paid before enrollment is considered complete and before a student will be placed on a class list. Students with any outstanding balances will not be admitted on the first day of class for the new school year.

#### **TUITION REFUNDS**

Families withdrawing students prior to June 1<sup>st</sup> shall be refunded the entire amount of tuition that has been paid for the 25-26 school year. After June 1<sup>st</sup>, families will be assessed a **\$1,000 per student withdrawal fee**, in addition to payment based on the number of days that each student was enrolled according to a formula established by the Finance Office. **Enrollment and Per Student Assessment (PSA) fees are not refundable and not transferrable.** 

#### SERVICE FEE POLICY

A service fee is charged at the time of the transaction in the school office for all point-of-sale credit card/debit card/gift card transactions. There is a 3% service fee for any payment of PSA Fees or Tuition. Below is the fee table for all Enrollment Fees, Athletic Activities, School Store Purchases, After School Activities, etc. Please note that you will not be charged a fee for paying with cash or check. **This service fee does NOT affect your FACTS account.**

#### TRANSPORTATION

There are a number of local school districts which provide bus transportation at no additional cost. Please call your local school district's transportation department to see if you live within one of these districts. Agreements must be made by the parents with the proper department of transportation. If you live outside of a district that provides transportation, contact your school district for possible reimbursement of transportation costs.
