



2026-2027 FINANCIAL INFORMATION

The following is a list of school tuition and fees. Effective January 22, 2026.

NEW STUDENTS (K-12)

Application Fee: \$125.00 per student due with online application.

Enrollment Fee: \$100 per student, increases to \$150 on March 13th, \$200 on April 24th.

A FACTS financial account must be completed upon student acceptance.

RETURNING STUDENTS (Grades 1-12)

Continuous Enrollment (Student Commitment Fee): \$100

Each family must have a signed Continuous Enrollment Form on file with admissions.

Each family is required to have an active FACTS financial account for the school year.

PER STUDENT ASSESSMENT FEE (PSA)

(Includes: Curriculum/Field Trip/Technology/Yearbook/etc.)

ANNUAL TUITION & ED CHOICE SCHOLARSHIP

Tuition payments and school fees are administered through FACTS Tuition Management Company, who offers an interest free payment plan. There is a yearly \$55.00 set up fee charged per FACTS contract (one per family).

If the student's family does not qualify for low-income per Ed Choice guidelines, the family will be responsible for the difference in tuition (Gap Tuition). * At this time, the State of OH has not indicated that there will be an increase in Ed Choice Scholarship amounts. As such, the scholarship rates for 2025-2026 are expected to remain.

WITHDRAWL

After June 1st, families will be assessed a \$1,500 per student withdrawal fee, in addition to payment based on the number of days that each student was enrolled.

OUR COMMITMENT

We believe that your tuition payments are an investment in your child's education and spiritual growth. Accordingly, the School's Board of Education accepts responsibility for recommending policies related to tuition amounts, payment methods, and overall financial planning. The Board also ensures that adequate financial resources are available to support the school while striving to keep enrollment accessible and affordable for families.

FEES

- **Application, Enrollment, and Re-Enrollment Fees** are non-refundable and non-transferable.
- **Per Student Assessment (PSA) Fee** is non-refundable.
- **Life Skills Fee: \$50.00**
(Elective for high school students; charged in addition to the PSA fee)
- **Senior Graduation Package:** Approximately \$100.00
(See the Senior Advisor for details and ordering information.)
- Devices, technology, non-consumable textbooks, and library books will be evaluated at the end of the school year. Families will be charged for lost or damaged items.

TUITION PAYMENT

All families are required to make tuition payments through **FACTS** using one of the following payment options:

A. Single Full Payment

The full tuition amount is paid in one payment through FACTS.

B. Monthly Payments – Automatic Bank Draft

Tuition is divided into ten (10) monthly payments and automatically deducted from a checking or savings account beginning in August. Payments may be scheduled for the 5th or the 20th of each month.

C. Monthly Payments – Credit Card

Tuition is divided into ten (10) monthly payments and charged to an approved credit card (American Express, Discover, Visa, or MasterCard) beginning in August. Payments may be scheduled for the 5th or the 20th of each month. A **3.05% FACTS convenience fee** will be applied to each payment.

LATE ENROLLMENTS

Tuition for students registering after the first day of school shall be prorated over the number of school days they will be in attendance, according to a formula established by the Finance Office. Enrollment fees and PSA fees are not prorated based on admission date. **If a family has not finalized their FACTS tuition account, the student will not be permitted to start school.**

LATE PAYMENTS

Families are responsible for notifying the Finance Office of any needed changes to their tuition payment plan or expected tuition amount. If no communication is received, the following policies apply:

A. Full Payments

If payment is not received by the due date, the Finance Office will contact the family within five (5) days to discuss the missed payment and alternative payment options. A \$25 late fee is subject to be applied to the account.

B. Monthly Payments

FACTS will assess a \$30.00 returned payment fee if funds are unavailable on the scheduled ACH or credit card payment date. The family's financial institution may also assess additional NSF fees. Additionally, a \$25 late fee is subject to be applied to the account.

Families who miss two (2) monthly tuition payments and do not make acceptable arrangements with the Finance Office within fourteen (14) calendar days of the second missed payment will be notified that their child(ren) will **not be re-admitted** to school in accordance with the Non-Admission Policy.

NON-ADMISSION OF STUDENTS DUE TO TUITION DELINQUENCY

School families failing to pay tuition according to the agreement which they have made with the Finance Office, or who have been unwilling to make suitable alternative arrangements with the Finance Director, will be informed that their child/children will not be readmitted to MCS. All accounts must be no more than two (2) months delinquent, and all delinquent accounts must be paid in full by June 30th each year.

DELINQUENT TUITION FROM PREVIOUS YEAR(S)

All unpaid tuition from previous school years must be paid in full before enrollment is considered complete and before a student is placed on a class list. Students with outstanding balances will not be admitted on the first day of the new school year.

WITHDRAWL FEES

Before June 1st: Families withdrawing a student will receive a full refund of any tuition paid for the upcoming school year and a withdrawal fee will not be charged.

After June 1st: Families withdrawing a student will charge a \$1,500 withdrawal fee (per student). Additionally, tuition charges based on the number of days the student was enrolled will be charged.

Enrollment Fees and Per Student Assessment (PSA) Fees are non-refundable and non-transferable, regardless of the date a student is withdrawn.

SERVICE FEE POLICY

Families can pay tuition and fees via a point-of-sale system in the MCS front office. A service fee will be charged at the time of the transaction for all credit card/debit card/gift card transactions. Below is the fee table for all point-of-sale transactions. Please note that you will not be charged a fee for paying with cash or check. This service fee does not affect your FACTS account.

TRANSPORTATION

There are several local school districts which provide bus transportation at no additional cost. Please call your local school district's transportation department to see if you live within one of these districts. Agreements must be made by the parents with the proper department of transportation. If you live outside of a district that provides transportation, contact your school district for possible reimbursement of transportation costs.
